### **Technical Articles**

#### Two restoration/repair tips

My 1967 427/400 had a couple of engine oil leaks that I wanted to repair. After replacing the oil pan gasket, I still had some oil seepage from the front cover harmonic balancer seal. It was enough seepage that while driving, the balancer would fling oil onto the nearby fuel pump and also onto the driver side front of the engine block.

I decided to try replacing the harmonic balancer front cover seal with the front cover still on the engine and with the engine in the car. This involved disconnecting the battery, loosening the alternator adjustment, removing the fan belt, removing the fan blade and fan clutch assembly, and then removing the water pump pulley and the crankshaft pulley. There was enough clearance between the balancer and the radiator to allow me to place a puller on the balancer and remove the balancer from the crankshaft. The Service Manual stated it would be necessary to raise the engine slightly to clear the frame front cross member, but I did not find that necessary.

**Tip #1:** This **Seal Puller with an adjustable head** worked well. It allowed me to work around the crankshaft snout and orient the puller handle to operate in the close confines between the engine and the radiator. It is a Lisle #56650 Adjustable Seal Puller. The head adjusts to five different positions to allow you to customize the orientation for your particular job. I was able to remove the front seal with a couple of pulls in two different locations on the seal.



While I had the front of the engine somewhat exposed, I cleaned all the grease that had accumulated on the driver side front of the engine block from the flinging oil (probably over several years.) When I did this, some of the orange paint was removed with the grease, so I was left with a good portion of bare cast iron. I wanted to use a brush-on engine paint because the close confines in front of the engine would make using a spray paint can impossible. Every brand of brush-on Chevy Orange engine paint that I could find was high gloss. This would not blend well with the rest of my engine paint, which was more of a low gloss, almost flat finish.

Tip #2: Flatten the gloss level of enamel paint using talc powder. Some research on line revealed a couple methods to flatten enamel paint before brushing it on. One method is to use a flattening agent, but I couldn't find anything for less than \$100 to add to my little pint of engine enamel. A second method is to add talc powder to the paint. I purchased a jar of pure talc powder from Amazon. I found that a 25% mix of talc produced a satin finish, and a 50% mix produced the desired low-gloss finish. The talc must be well stirred into the paint for a successful outcome.




### **C6 Convertible Top Bind**

If you own a C6 convertible you may have noticed that when raising or lowering the top the back window contacts the clamshell during this operation. This can happen with both power and manual tops. I had this issue with my 2007 C6.



I did some research and found a GM technical service bulletin #09-08-67-013C that addresses this concern. The cause is related to the stretching of the limiting straps, it instructs the technician to open the top to the vertical position and to find the end of the limiting straps at the lower rear window area. You will note I used a small ratchet strap to keep the top in the folded position. You can see the upper end of the limit strap attached to the top frame with a silver rivet. This is the **driver's side** with the







The TSB instruct the technician to remove the lower attaching screw and move it ½ inch making the straps shorter. This is to be done evenly on both sides. I found it extremely hard to find the lower

attachment points on my manual top but did note the upper attachments were easily accessible being located directly above the driver's and passenger's seat on the top frame. I reviewed my findings with my convertible top installer, and he saw no negative effect of changing the relocation procedure to the upper strap mounting.

I proceeded to drill out the rivets, I added a pair of vice grips to the back side of the rivet to keep it from spinning while I drilled. After removing the old rivet, I then folded the strap over, reducing the length by about 1 inch. I tried the ½ inch application but did not feel it made much difference. I then used an awl to push through the old hole and created a new one matching the hole in the top frame. This picture is from the **passenger's side** with strap coming up from the left rear in the picture.





I used a bolt/nut/washer to attach the strap back to the top frame, repeating the procedure on the other side. The results were a success. I now have ¾ of an inch clearance when the top is raised or lowered.

\*Note this applies to both manual and power tops for C6.

Hope this helps.
